I hope you are well.

We are finalising details of the section 106 contributions for NS1 site. We previously corresponded in June about whether there was any sports facilities within the parish that had identified capital projects which contributions could be directed towards. Are you able to confirm whether the parish council has identified any specific need financial support for sports related capital project in the parish? My email of the 4 June refers (extract below) -

The developer has committed to providing financial contributions for these and now the district council is exploring where this need can be best met. The starting point for this is Graveley village. It would be useful to know in the first instance the specific local sports clubs active in the village, what spaces they use and whether you are aware of any shortfall in provision of space (pitches, courts) or facilities (changing etc) for these. I hope you are well.

You may know that Members resolved to grant planning permission for this development earlier in the year. We have begun to work on drafting a Section 106 with the developer. There are two additional issues which we did not previously discuss which we would like the parish council's consideration on. These are set out below.

Allotments

As part of the development, the developer will lay out 0.6ha of allotment space adjacent to the northern boundary south of the cricket club pitch. This will be to the National Allotment Society Standards as set out in the publication "21ST CENTURY ALLOTMENTS IN NEW DEVELOPMENTS - Practical, design-led and policy-based guidance for planners and developers who are looking to include allotments in new developments" - https://thenas.org.uk/uploads/NAS%20Development%20Brochure%202023%20LR.pdf). As

you know, the application site falls within Graveley parish and it is normal practice to offer these facilities to parish council in the first instance. I would be grateful to understand whether this is something which the parish council would be interested in taking on the responsibility for?
